Korea Entry Requirements

All nationals who enter Korea must have either Korea Electronic Travel Authorization (K-ETA) OR Visa.

所有人士進入韓國必須持有韓國電子旅行許可 (K-ETA) 或簽證

“K-ETA”: Nationals from countries that have visa-waiver or visa-free agreement with Korea and whose purpose of visit is tourism, business, discussions, conferences, short-term study with stay below 90 days etc.

K-ETA: 與韓國有免簽或免簽協議國家的公民，其訪問目的是旅遊、商務、討論、會議、停留時間不超過 90 天的短期學習等。

“Visa”: Nationals who are not eligible for K-ETA, K-ETA application is denied or purpose of visit is not covered under K-ETA

“簽證”: 不符合 K-ETA 資格、K-ETA 申請被拒絕或其訪問目的不屬於 K-ETA

Korea Electronic Travel Authorization (K-ETA)

韓國電子旅行許可 (K-ETA)

Apply the K-ETA via the K-ETA official website (www.k-eta.go.kr) and **obtain a K-ETA approval before boarding the flight / vessel to the Republic of Korea.** The K-ETA is valid for multiple entry and the application fee is 10,000 KRW per person. The applicant can check the result within 72 hours from [Check K-ETA Results] after submitting the K-ETA application.

旅客須事先於官方網站(www.k-eta.go.kr)申請韓國電子旅行許可(K-ETA)，獲得K-ETA批准方可登上前往韓國的航班及船隻。K-ETA可多次入境，費用每人10,000韓元。一般可於72小時內於[K-ETA申請結果查詢]查詢申請結果。
