## Visa Requirements to THAILAND

- Passenger is allowed to embark and disembark in Thailand. Kindly refer to below visa table.
- Visa on arrival 2000THB & Handling Fee of Immigration 500THB sums up to total 2500THB.
- Passenger not required to purchase travel insurance.
- Vaccination certificate is required either hard copy or E-Copy.
- Children 13 years and below unvaccinated must be accompanied by fully vaccinated Parents/Guardians.

\*\* Passport holders of Vietnam and Hong Kong are entitled for tourist visa exemption scheme. Meanwhile, Thailand also holds bilateral agreements on visa exemption for holders of diplomatic, official and ordinary passports for a visit of not exceeding 30 days with Vietnam and Hong Kong.
