

Visa Requirements to VIETNAM

- Passenger is allowed to embark and disembark in Vietnam. Kindly refer to below visa table.
- Visa on arrival & Handling Fee of Immigration sums up to total 20SGD.
- Passport validity must be above 6 months.
- Passengers should keep and hold the stamped landing card for going ashore / joining shore excursions at all port of calls in the ship 's itinerary.
- Passengers that applying Visa on Arrival will require Two color sized passport photo for the Vietnam visa issuing.
