

Terms and Conditions

1. General

One Piece Asia Hunt is co-organized by **Lorrypop Studio Sdn. Bhd.**, **Womb Creative Sdn. Bhd.**, and **Incubase Studio Asia Limited**, with **SplashMania Waterpark, Gamuda Cove** as the official venue partner.

By completing the official entry form, submitting payment through **Ticket2U** or **Klook**, or downloading and using the **One Piece Asia Hunt App** (the "Application"), participants agree to these Terms & Conditions.

Registration is confirmed upon successful payment and issuance of a confirmation email. The Application is developed and operated by **Lorrypop Studio Sdn. Bhd.** ("Service Provider") as an ad-supported service.

2. Ticketing & Admission

- FREE park admission applies only to **children aged below 3 years** with a paying adult.
- **Age Categories:**
 - **Child:** Guests aged **3 – 12 years**
 - **Adult:** Guests aged **13 - 59 years**
 - **Senior Citizen:** Guests aged **60 years or above**
- Ticket prices are based on birth year.
- Guests must present valid identification documents (NRIC, MyKid, I-Card, Passport, or Multiple Entry Visa) for verification before park admission.
- Guests must adhere to all safety rules and regulations of the slides and rides.
- **OKU Guests must present a valid disability certificate for verification.**
- **Children below 12 years old** must be accompanied by an **adult (18+ years old)** at all times.
- Guests must adhere to [SplashMania General Admission T&Cs](#).

3. Registration

- Participants must provide accurate and complete information; errors may result in disqualification without refund.
- By registering, participants consent to receive event-related updates via email or phone.
- Group participation is encouraged. Team leaders must ensure all members meet eligibility and safety requirements.

4. Ranking Participation Rules

- Participants may choose to compete in either the **Group Challenge** or **Individual Mode**, but **not both** for ranking eligibility.
- If a participant joins the Group Challenge, they will **not be eligible** for individual rankings, and vice versa.
- This rule is designed to ensure fair competition and ranking integrity across all formats.

5. Replay Policy

- Participants are welcome to **replay or revisit** the event to try a different mode (e.g., switching from individual to group or vice versa).
- However, new mode replaying does **not affect previous rankings**, and the **ranking exclusivity rule still applies**: you can only qualify for **one leaderboard result**.

6. Package Terms & Conditions

- **Validity: June 19 - July 31, 2025** (excluding June 25, July 2nd, 9th, 16th, 23rd, and 30th)
- This package **cannot** be combined with ongoing promotions or discounts.
- Tickets are **non-transferable, non-refundable, non-exchangeable for cash, and not for resale**.
- No refunds for cancellations due to **inclement weather**.
- **Attractions are closed on Wednesdays**, except on Malaysian school/public holidays.
- **Race kits** will be redeemed at the One Piece Redemption counter at **SplashMania Waterpark, Gamuda Cove (near the entrance)**.
- The organizer reserves the right to modify or cancel the event or promotions without prior notice.

7. Park Rules & Regulations

Prohibited Items & Conduct

- **No outside food & drinks** allowed.
- **Glass, sharp objects, surfboards, bodyboards, or personal tubes** are prohibited.
- **Fighting, abusive language, and disruptive behavior** are strictly prohibited.

Safety Requirements

- Only **approved swimwear** is allowed.
- Guests **must use** tubes/sliding mats on specific rides.
- **Height & weight restrictions** apply to all rides.
- Certain attractions contain **bright lighting/strobe effects** which may trigger **photosensitive epilepsy**.

Personal Belongings & Locker Rental

- Guests are responsible for their **own belongings**.
- Locker rental is available.

Weather & Refund Policy

- **No refunds** due to inclement weather.
- No **cancellations, refunds, replacements, or extensions** after purchase confirmation.

8. Safety & Health

- Participants are responsible for ensuring they are **physically fit** to participate.
- The organizer **is not liable** for any injury, illness, or death during or after participation.
- Participants are **strongly advised** to consult a medical professional before the event.

9. Event Changes & Cancellation

The organizer reserves the right to:

- **Cancel the event without refunds** if bad weather persists.
- **No refunds** for cancellations or schedule adjustments.

10. Media & Publicity

- By participating, guests consent to their **images, videos, and media** being used for **promotional purposes** without compensation.

11. Event Conduct & Safety

The organizer reserves the right to:

- Disqualify participants for **unsportsmanlike behavior** or failure to follow instructions
- **Remove participants** deemed medically or physically unfit
- **Reject or dissolve crews** that violate event conduct
- **Parents/guardians** are responsible for the safety of minors at all times.
- **Group challenges** require team cooperation and fair play.

12. Liability & Indemnity

- Participants **acknowledge all risks** and participate **at their own risk**.
- The **organizer, sponsors, and partners** are **not liable** for any loss, injury, damage, or expenses before, during, or after the event.

13. App Terms & Conditions

Intellectual Property & Restrictions

- Unauthorized **copying, modification, or extraction** of the app source code is **prohibited**.
- All **intellectual property rights** remain with the **Service Provider**.

App Modifications & Charges

- The **Service Provider** reserves the right to **modify the app or charge for services**.
- Any charges will be **clearly communicated** beforehand.

Personal Data & Security

- The **Application processes personal data** to provide services.
- Users are responsible for securing their phone and **access to the app**.
- **Jailbreaking/rooting** is strongly discouraged due to security risks.

Third-Party Services

- The app relies on third-party services (e.g., **Google Play Services, Facebook**) which have **separate Terms & Conditions**.

Internet & Network Usage

- Some app functions require an **active internet connection**.
- The **Service Provider is not responsible** for network issues.
- Users are responsible for **mobile data charges**, including roaming fees.
- Users must obtain **permission from the bill payer** if they are not the device owner.

User Responsibility

- Users must **ensure their device is charged** to use the app.
- The **Service Provider is not liable** for loss due to battery depletion.

Accuracy & Liability

- The **Service Provider strives** to keep the app updated but relies on **third-party information**.
- **No liability** for losses due to inaccurate or outdated app information.

App Updates & Termination

- Users must accept **app updates** when provided.
- The **Service Provider may discontinue** the app at any time **without notice**.
- Upon termination, users must **stop using and delete** the app.
